- Not to ring the buzzer of FLAT 107, CAMPDEN HOUSES, Peel Street, W8 7PJ
- Not to contact directly or indirectly the resident of FLAT 107, CAMPDEN HOUSES, Peel Street, W8 7PJ
- Not to contact directly or indirectly the resident of FLAT 105, CAMPDEN HOUSES, Peel Street, W8 7PJ
- Not to intentionally jump and bang on your floor to cause noise within FLAT 105, CAMPDEN HOUSES, Peel Street, W8 7PJ
- Not to act in a manner which is likely to cause harassment, alarm and distress to the residents of CAMPDEN HOUSES, Peel Street, W8 7PJ
- Not to play music at a level that can be heard within neighbouring properties of CAMPDEN HOUSES, Peel Street, W8 7PJ which causes a disturbances

The conduct you have displayed, or are responsible for, must stop otherwise you will be liable to be issued with a Community Protection Notice.

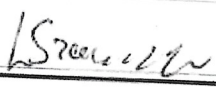
You have until - 07/05/2025/13:00 - to ensure the offending conduct stops in order to prevent a Community Protection Notice being issued to you.

If you are issued with a Community Protection Notice and fail to comply with its requirements you will commit an offence for which you will be liable on summary conviction -

(a) to a fine not exceeding level 4 on the standard scale, in the case of an individual;

(b) to a fine not exceeding £20,000, in the case of a body.

If you fail to comply with the terms of the Community Protection Notice, the Court may order remedial works to be carried out to address the detrimental effect caused by your conduct, and for which you may be liable to any costs.
