Hello Michael,

yes, don't worry, I am a serious person and also a very sensible one for the poorest. It is a great pleasure and honour for me to be helpful and useful for the girl.

This girl needs help, there is nothing else, what the girls needs now immediately.

Okay let's start, because there is no time to waste as I will also depart next Wednesday, 15 April to Islamabad and will remain there until the 25 April evening.

As I will be in the mountains of Azad Kashmir (we have there a humanitarian projects for the children orphans, victims of the earthquake in the year 2005, I am mostly of the time not available with emails, the Blackberry there won't work. But I have always my mobil phone with me, so for urgent informations and communications I beg you to send me sms on my number [REDACTED] okay?

Some questions to avoid misunderstandings: Who is doing the photos and television footage? Your press photographer there? I saw on your homepage, that the girl is already in hospital right? Or is the photo used there not recently made? Is it clear for him/them that the photos made as soon I sign the contract til the ultimatum of medical treatments (I guess several years it will need) cannot be sold, cannot be forwarded for other people, journals, organisations? Could we – your organisation Journalism without borders – and me in quality of chairperson of CF also make a kind of written Agreement?

You are speaking about a "contract"...In my opinion we need 2 contracts, one contract between the hospital and CF, that the hospital doesn't forward any medical and private informations regarding the girl to other persons, journals, organisations and won't allow any other persons, photographer to make pictures of the girl in the hospital, correct and that in case of demands regarding informations and pictures the concerned person/journal has to contact CF by email [REDACTED] and ask for permission. In this case CF would allow but only if the person/journal donates a certain amount (which will be established between me and the person) to the account of CF with the purpose to finance the medical treatments of the girl The other contract should be between the parents and CF with the exactly same content. Either the medicals in the hospital as well as the parents do have to know, that if they doesn't respect the "rules" and the contract, CF will stop the medical support immediately. Do you agree? Of course it should be also clear, that every medical treatment respectively every operations in future is a new "financial project" for CF, and we have to decide it every time again, if we can participate with a part of the costs, okay? I cannot promise now that CF will and can always pay these costs as it is a big sum...I hope you have comprehension for this kind of vision.

Thank you very much Michael for your kind and generous offer to donate us the sum which you had collect until now for the girl. Thank you very much for this!

Don't forget, that we need beside the photos and the film also a kind of private and medical report on the girl and photos from the parents, brother and sisters, home etc. Thank you a lot.

By the way: What do you think about – after I will return from Pakistan – to meet and also to discuss our collaboration and how we can make it more effective. You and your wife or girl friend would be very welcome for a weekend as guest in our wonderful property in Varese, we have also there a guest lodge and a 3 ha botanical park and an antic Liberty-Villa..you would enjoy it very much. Pls think about my invitation and take it for serious ☺
