Mr Mołodyński has uploaded his pictures to Kontakt24, a website run by biggest news station in Poland, TVN.

It seems that CEN have nicked the pictures from there and then they claimed that it Mr Mołodyński quotes was also taken from there and then TVN edited the site to remove it.

I asked TVN if they agreed for CEN to use their stores and if upload of Mr Mołodyński was edited. As you can see from the e-mail below, she say that they do not edited it, but they have no means to tell if Mr Mołodyński has edited it after iploading. This is the statement I got from Aleksandra Majda from TVN (to whom I was directed by the station's spokesperson) on the matter:

1. Central European News is not among our regular partners. Sometimes other outlets ask to use our materials, but we have no record of Central European News doing so.

2. Definitely after the story uploaded by Kontakt24 user to our website is checked and published as a news item, user has no means to edit it. We can't say, due to new computer system, if mr Molodyński edited his story in first two hours since he uploaded it to our system, but no respectable news agency would base their story on user-provided information without checking it first.

But, wait for it, later she told me:

Panie Tomaszu,

*Niestety nie mogę się dla Pana wypowiedzieć. Nie dostałam zgody przełożonych
Przykro mi
Aleksandra Majda*

Which trasnlates to "Unfortunately I cannot give you a statement. My superiours did not allowet it. I am sorry".

My feeling was that TVN just simply did not wanted to have anything to do with that story.
