Yes we already do a lot of work for buzzfeed but not anything you'd be interested in, it's the tabloid stories that provide the funding for everything else we do.

Mind you I reckon I'm happier with that than taking money for PR or marketing firms to include stuff in our news feed. Or a sponsor with vested interests for that matter.

Turned down a small fortune yesterday to include a story about an Austrian/International celebrity who'd won an award for charity work.

What I want to do is deliver finished investigations that we do here simply because we are interested in them, like the child trafficking, and to have a network of editors like you trying to place the items where they will probably find the most interest.

Money is not the main priority, happy also to work for free if the story is the right one, at the end of the day it all helps to build up a reputation for what we are doing.

I'm happy to talk in February, although I do have a story on corruption involving Microsoft and the former PR agency that used to employ the British justice minister Grayling which is written and ready to go - are you interested in looking at it? I have all the leaked documents necessary to keep the lawyers happy.

I had been planning to do it for my friend at private eye exclusive but he decided the Grayling angle was too weak. He is quite correct of course, the only connection really is that it's the place he used to work and I don't think he had anything to do with the Microsoft deal which I found out about.

Anyway, also happy to leave it until February where I'm sure we will have some other ideas and good luck with the book project, sounds very exciting. I can't say that my books have ever been very well read, but I've always enjoyed doing them and I consoled myself with it's not getting there, but it's how you get there that counts.

Pass my regards onto Jonathan, and I will leave you with my Strasser story sent earlier this week to the UK media.

A corrupt MEP caught by a British newspaper offering to propose amendments to EU laws in exchange for 100,000 EUR (78,000 GBP) a year has been allowed go back to work just two months into a three-year-jail term.

Austrian Ernst Strasser, 58, also a former interior minister of Austria, was originally given a four-year term in 2013 after he was filmed by reporters from the Sunday Times newspaper offering to pursue amendments to a planned law on hedge funds for cash.

After a retrial, he was sentenced to three-and-a-half years in jail for bribery by a Vienna court in March last year, which was reduced again in October by the country's highest court to three years taking into account the massive fall from grace that he had experienced by his actions.

Strassser's lawyer Thomas Kralik had appealed the sentence in March, saying: "To a certain extent this was entrapment. Had they not put the carrot before his nose, there would have been no case to answer."

And he added: "He is now politically and socially a dead man." However Strasser, a member of the conservative Peoples' Party (OeVP) who had served as interior minister from 2000-2004, has spent just eight weeks in prison since beginning his sentence towards the end of last year and is now allowed to leave on a daily basis in order to start work as a consultant once again.

He is obliged only to sleep in the jail, arriving back at his two man cell in the late evening.

When his jail sentence was finally confirmed, Supreme Court President Eckart Ratz said it was "vital for democracy to fight against people who use politics to line their own pockets". He then addressed Strasser directly as he told him: "An EU parliamentarian who is corrupt is an evil that destabilises and calls into question the functioning of the European Union."

Strasser is being held at the prison in Simmering on the outskirts of the Austrian capital Vienna.
